1. All participants must be currently enrolled in 4-H
2. All riders **MUST** wear riding boots **AND** an **ASTM helmet AT ALL TIMES WHEN MOUNTED.**
3. **LONG SLEEVED WESTERN TYPE SHIRTS** (or the 4-H Equivalent) **ARE REQUIRED WHEN COMPETING**
4. 4-H rules will be followed. If needed the WHO rule book will be consulted
5. **Decision of show officials are FINAL!!!!**
6. **Unsportsmanlike conduct or inhumane treatment of animals will NOT be tolerated and can result in disqualification**
7. Riders unable to control their horses may be excused from the arena
8. Western tack is required. Tack, equipment, or attire may be subjected to inspection by show officials.
