Is There A Stream Or Pond On Your Property In Need Of Riparian Restoration?

The Oregon Conservation Reserve Enhancement Program (CREP) could be the solution to assist you. The CREP provides a cost-effective way for landowners to restore and enhance riparian vegetation along streams and around permanent water bodies.

An annual rental rate is offered, plus cost-share payments of up to 75 percent of the eligible costs to install conservation practices.

Administered through the Farm Service Agency (FSA), the CREP addresses conservation issues such as impacts to water resources, soil erosion, critical habitat, and reduced habitat for fish populations such as salmon.

The CREP is a community-based effort that emphasizes results-oriented projects, while presenting an opportunity to foster a partnership between producers, the state and federal governments,

and the local soil and water conservation districts.

During the 10 – 15 year contract period the CREP provides payments to producers who offer to voluntarily remove riparian areas from production through the creation of a buffer (minimum 35') along the stream.

Common practices include riparian fencing, riparian planting, weed control, and off-site watering facility establishment. The program offers an additional one time sign-up incentive payment and a practice-completion payment.

Multi-Peril Crop Insurance Program

The Risk Management Agency reminds producers of winter and spring sales closing dates for the Multiple Peril Crop Insurance programs and the Adjusted Gross Revenue Pilot, and the Adjusted Gross Revenue-Lite programs available across the PNW which cover most farm-raised crops, animals and animal products. AGR and AGR-Lite are based on a producer's five-year historical tax form information and an annual farm report to provide a level of guaranteed revenue for the insurance period. USDA will pay a portion of the premium.

Producers should contact a local crop insurance agent to learn additional program details. If there is no coverage in your county for a specific crop under the traditional MPCPI program, please ask your agent whether you would be eligible for coverage under a written agreement. *(this information is from last year,)*
