### Who to Nominate:

Individual adults or groups who have made a major contribution to the County 4-H program over a period of years.

### How to Nominate:

Candidates may be nominated by local 4-H leaders, 4-H members or other interested individuals in the county. Nomination forms are available at the Extension Office. Nominations are to be turned in to the Extension Office by **October 1 by 5:00 p.m.** Final selections will be made by the Awards Committee. Awards will be presented at the Fall Recognition Festival.

### **CRITERIA FOR SELECTING DOUGLAS COUNTY 4-H DISTINGUISHED SERVICE AWARDS**

1. Major contribution at the County Level.
2. Types of assistance (educational, financial, advisory, legislative, informational).
3. Significance and quality of contribution (breadth and depth of service to the 4-H youth program and effectiveness in helping to meet the goals of 4-H).
4. Tenure (must represent continuing support over several years).
5. The Distinguished Service Award is not to be awarded to employees of the Oregon State University Extension Service nor to employees of the 4-H Foundations and related 4-H Associations.

\*\*\*\*\*

1. This award may be received only once.
2. Selection is by the Awards Committee at a meeting held prior to the Recognition Festival.
3. Nominations must be submitted to the Extension Office by **October 1 by 5:00 p.m.**
4. One annual award will be presented with a second award given in case of a tie (e.g.: group and individual).
5. Nominations not selected will be held for next years award selection, each nomination will be valid for 3 years.
6. The committee will inform the recipient of the award and date of presentation.
7. Since this award is for a "major contribution and distinguished service", it may or may not be given at the discretion of the Awards Committee.
