

Bankruptcy Debtor Education Program

“Moving Forward to Financial Security”

If you have filed for bankruptcy, you **MUST** complete an approved Debtor Education program prior to discharge. Oregon State University Extension Service is an approved provider of the debtor education course required prior to completing bankruptcy.

Class dates (select one):

- May 6th from 1–3 p.m.
- June 12th from 6–8 p.m.
- July 1st from 10 a.m.–Noon
- Aug. 5th from 1–3 p.m.



- Sept. 9th from 10 a.m.–Noon
- Oct. 7th from 1–3 p.m.
- Nov. 4th from 6–8 p.m.
- Dec. 2nd from 10 a.m.–Noon

Class Cost: \$50 for each Bankruptcy Case Number

- Payment by cash, check or money order payable to the OSU Extension Service, prior to the start of class.

Class location: OSU/Lane County Extension Service Auditorium, 950 West 13th, Eugene.

To Register:

- You must *pre-register five business days in advance* of class to receive a certificate of completion on the day of the class.
- Complete the registration form, and bring or mail it with payment to the OSU/Lane County Extension Service, 950 W. 13th Ave., Eugene, OR 97402.

Other Information:

- Participants are **required** to bring photo ID to class.
- Please arrive 20 minutes before class for check-in. Late arrivals will not be admitted to the session.
- Children may not attend class.
