

HOW TO REGISTER FOR FAIR

The **Fair Entry Form** is used by **both** 4-H and FFA members. The 4-H superintendents and FFA advisors use these forms to register you in a particular exhibit class and/or contest. **Use the appropriate form for each project area in which you wish to register.** For instance, use the sheep form to enter all the classes you are showing, the clothing form for all the clothing exhibits you are entering, etc. You may photocopy the form if you need additional copies. Keep a copy of your form for reference.

To exhibit in a project, you must be enrolled in that specific project (see 4-H Fair Policies for special exceptions). For instance, if you plan on exhibiting a photograph, you must be enrolled in the 4-H Photography project by the final 4-H fair eligibility enrollment deadline of June 1, 2009. Also, each 4-H/FFA participant must **return all completed forms and the camping fee to the Linn County Extension Office, P.O. Box 765, Albany OR 97321 by June 5, 2009.** The forms needed are:

**International Show Ring Code of Ethics Form
Camping Reservation Form and fee – with a separate check**



THE DEADLINE FOR FAIR ENTRIES IS FRIDAY, JUNE 4, 2010

Members who miss this deadline due to extenuating circumstances may submit their entries, with a written explanation detailing why they couldn't meet the deadline, no later than June 11, 2010.

EXAMPLE

Let's say you are J. Doe. You are a 4-H member and you are going to show a market lamb and a cake.

1. Read the fair book carefully so you register in the correct class and use the correct class numbers. Class numbers must include all 9 digits.
2. Fill out the Fair Entry Form for the market lamb by checking either 4-H or FFA and entering the required information about the animal (breed, date of birth, number of head).
3. Fill out another Fair Entry Form for the cake
4. Be sure to include Showmanship and Market classes on your Entry Form

HOW WE ARRIVED AT THE CLASS NUMBERS

Definition

1st digit - Curriculum area

As outlined in the Project Area file for the Enrollment system

2nd & 3rd digits - Project area

As outlined in the new Project Area file for the Enrollment system

4th digit - Class or contest

0-4 - Exhibits,

Static Exhibits:

1 - Exhibits

2 - Educational Displays

3 - Recipes (Foods), Creativity (Clothing), Dried Materials (Flowers)

4 - Arrangements (Flowers), Service (Clothing)

Animals and Animal Products

0 - Guide Dogs

1 - Exhibits (Animals)

2 - Production Classes

3 - Market

4 - Eggs, Pelts, Wool

5 - Showmanship

6-8 - Contests

6 - Presentations

7 - General

8 - Gaming

9 - Judging Contests

5th and 6th digits - Breed, species, level/type contest

00 - if class has no breed or species, or if unknown

01-99 - Breed, species, level/type contest, etc.

7th and 8th digits - Sub-Class

00-99 - Used to distinguish different sub-classes

9th digit - Level

0 - No Level

1 - Junior

2 - Intermediate

3 - Senior

4 - Club
