FORWARD

The FFA is the National organization of students enrolled in high school Ag Science and Technology classes throughout the U.S. and Puerto Rico. The Oregon FFA includes all of the high school chapters in the state and is under the supervision of the State Department of Education.

FFA makes a positive difference in the lives of students by developing their potential for premier leadership, personal growth and career success through agricultural education. Every FFA project is the extended application for secondary agricultural education programs. Participation in fairs and livestock shows is recognized for its educational value and the stimulation of supervised agricultural experiences under the supervision of the Chapter Advisor and the cooperation of the fair management.

ALL ANIMALS THAT ARE ENTERED IN THE FAIR ARE SUBJECT TO USE FOR LIVESTOCK JUDGING CONTESTS.

FFA GENERAL RULES

1. All entries must be from projects carried on as a regular part of the high school Ag Science and Technology student's program. They must be **owned and managed** as part of the Ag Science and Technology student's supervised agricultural project by the student showing them for a period of at least 50 days **before** the county fair. Graduates who have been active FFA members and have paid local, state and national dues may compete for the summer immediately following their senior year. Incoming freshman Ag Science and Technology students who have registered in agriculture with projects are eligible to show at the county fair in the FFA division.
2. Individual projects may only be shown in 4-H or FFA, but not both.
3. All FFA exhibits including beef, sheep, swine, and farm machinery, need to be checked in to the fair on Tuesday before 9 p.m.
4. All FFA exhibits must remain in the exhibit area until Sunday, or until they are released by the superintendent of the Linn County 4-H-FFA fair or the County Fair Board. Any exhibitor who violates rules will automatically forfeit his premium money.
5. In case there is no competition or the entries are deemed unworthy of the premiums offered, the premium will be awarded at the discretion of the judges.
6. All members will compete in showmanship.
7. Every member will be personally responsible for having his exhibit in the ring or other place designated when the class is called or the exhibit judged. If the entry is not in the proper place and at the proper time before judging, the entry will not be allowed to compete.
8. Registration papers are not required for county livestock FFA exhibits. However, the breeding livestock which is shown must have definite breed characteristics and should be purebred. Questionable animals will be entered at the discretion of a sifting committee made up of the FFA fair superintendents.
9. The management reserves the right to refuse entry to any animal that shows evidence of a contagious disease upon clinical examination by a qualified veterinarian.
10. All exhibitors are responsible for cleaning up their exhibit space before they leave the fairgrounds.
11. Entries per person are limited to 2 head of livestock in each class except as otherwise explained. Entries in crops, fruit and vegetables are limited to one entry per person per class. Entries in farm mechanics are unlimited per person in division and class.
12. Champion Showman in beef, sheep, dairy and swine will compete for the FFA Master Showman of the Fair.
13. ALL ANIMALS THAT ARE ENTERED IN THE FAIR ARE SUBJECT TO USE FOR LIVESTOCK JUDGING CONTESTS.

DIVISION 1 - FFA Agriculture Mechanics

1. All shop entries must be the products of Ag Science and Technology students or active FFA members during the current year.
2. A sifting committee may eliminate from exhibition any exhibits that do not come up to standards.
3. Projects must be complete.
4. Projects may be shifted from one class to another at the discretion of the section superintendent.
5. When there are five or more projects of the same kind, a separate class may be created (for example, picnic tables)
6. Batteries are to be disconnected from power driven projects.

7. Chapter advisors are responsible for delivery and marking their chapter shop display.
8. The Danish system will be used in judging the mechanics exhibit.

DIVISION 3 - FFA Nursery Group

All nursery entries will be scored on the Danish system.

If an exhibitor makes more than one entry per class, each entry must be listed separately on the exhibitor entry form.

CLASS A - Nursery Propagation

Entries are to be a demonstration of propagated materials by FFA students. A student may enter up to 10 entries per class provided each entry is of a different cultivar. Each entry to consist of 2 plants of the same genus, species, and (except for #11-5 different species). Each plant to be displayed in a separate identical commercial-type container. A single cultivar may be used only once, except in Nursery Exhibit #11.

CLASS B - NURSERY COMMERCIAL

Market size items balled and burlapped, or in cans. Entries are limited to members who have nursery projects for more than one year. Records books must be brought in with entries. A student may enter up to 10 entries per class provided each entry is of a different cultivar. Each entry to consist of two plants of the same genus species and cultivar (except #7-5 specimens; #9-5 specimens; and #10-1 specimens). Each plant to be displayed in separate, identical commercial type containers. A single cultivar may be used only once except in Nursery Commercial #9 & #10.

CLASS C - Floral

A student may enter up to 10 entries per class provided each entry is of a different cultivar. Each entry shall consist of two specimens of the same genus, species and cultivar or the same number specified.

Cut flowers, 3 specimens, bud vase furnished.
