# GENERAL EXHIBITOR RULES

1. All animals brought for exhibition are at the owner's risk. The Show Board will not be held responsible for injuries incurred by animals or injuries or damages inflicted on a third party by said animals and in no event will be held liable for the death of an animal.
2. No other animals allowed on the grounds other than exhibits for this show.
3. FFA Chapters or 4-H Clubs exhibiting as a cooperative exhibit shall abide by the same rules as the individual exhibitor.
4. Agents and instructors may make all entries for their counties or chapters.
5. No refunds of any kind will be made.
6. Any checks returned NSF would be charged a \$25 handling fee. A money order or cash will be mandatory for payment.
7. Exhibitors must keep pens in show condition to qualify for awards.
8. Exhibitors must provide their own feeding and watering equipment.
9. Bedding will be available on the grounds.
10. Stall cards should be in place by 8:00 a.m. Friday.
11. FFA Chapter advisors or authorized substitute and county agents or designated 4-H Leaders are responsible for their Chapter and County's delegation's conduct while attending the show. Any problems not settled by those responsible will be brought before the rules enforcement committee whose action will be final.
12. Animals can be exhibited at the show by other than the owners if illness or accident during the show prevents the owner from showing the animal. However, a bona fide 4-H or FFA member in his or her place should show these animals. The Show Board shall review all of these cases.
13. All classes will be divided by weight not organization. (4-H and FFA will show together)
14. The superintendent has the authority to change, combine or cancel classes to fit the livestock entries.
15. All premium and sale checks will be mailed to the address on the entry form.
16. Insurance coverage for 4-H and FFA registered at the show is in force only on the grounds or while participating in sponsored events.
17. CHECK OUT AND RELEASE OF ANIMALS. Proper checkout papers from the Show Auction office are required on market animals. Jackpot only entries may leave after classification on Friday. Market Beef should have proper destination papers and brand transfer slips. Be sure to clean the bedding out of your pens before you leave the show. A \$20.00 per pen cleaning fee will be assessed for each pen not cleaned.
18. The Show Board shall select a committee for the specific purpose of supervising and enforcing rules and regulations as outlined in this booklet.
19. All jackpot animals must have an ID (ear tag) prior to arrival.
20. The show Committee reserves the right to decide any points not already covered by listed rules. Decisions made are final.
21. All animals entered in the show are subject to being used in the judging contest. Every effort will be made to contact the owner and or advisor prior to the contest.

# GENERAL MARKET SALE RULES

## SALE ORDER - Beginning at 9:15 AM Swine – Beef - Lambs

Prior to the sale, all buyers must register at the sale office and receive a bidder's number

1. All purchases must be paid for at the office prior to release of the animals unless prior arrangements have been made. Checks should be payable to Mid Columbia Junior Livestock Show and delivered to the office following the auction.
2. All animals that make weight are consigned to the Mid-Columbia Junior Livestock Show for sale.
3. Sale weight, ear tag number and seller's name will be shown on sale sheet.
4. All bidding will be on a pound basis.
5. Animals designated resale at time of sale cannot be repurchased.
6. The total bid price must be paid to the Mid-Columbia Junior Livestock Show, not just the commission, on any animal bought back by the exhibitor (includes exhibitor's immediate family).
7. A maximum of 5 percent of gross sale and all add-on support handled through the show books will be withheld for expense.
8. Animals will be sold in the order of ribbon placing. 1st-Blue, 2nd-Red. Grand Champion and Reserve Grand Champion animals will sell one and two.
9. Only one weight permitted. Animals with weights in question will be taken off scale, scale rebalanced, and animal re-weighted immediately. New weight will stand. Weighing to be performed by show appointed weigh masters only. All published weight limitations will be enforced. Prior to show, scales are checked and certified by State Weights and Measures Division.
10. All exhibitors must be on call at their exhibits during the auction sale unless previously excused. Failure to comply could result in the loss of the sale of their animals.
11. Exhibitors having sifted animals must make their own arrangements for selling those animals. The Show Board cannot be responsible for these animals.
12. If an animal is condemned at slaughter for health reasons, it will be the seller's responsibility, not the shows, or the buyer's.
13. Allow approximately one month for your money from sale of animals. The checks will be mailed to the address on the entry form.
14. REMEMBER! CHECKS ARE VOID AFTER 90 DAYS
15. The sale office will not mail out billings of less than \$50.00. Please make payment arrangements with the office prior to the sale.
16. Exhibitors must bring their pledges and add-on support to the office in the form of cash or a check made out to the Mid-Columbia Jr. Livestock Show prior to the sale.

# MARKET STOCK SALE DIVISION

## THESE ANIMAL WILL SELL SUNDAY MORNING AT 9:15 AM

1. Each exhibitor may enter only two animals in the market stock sale division
2. Classes will be divided by weight into equal groups by the management
3. White ribbon animals will not sell in the market stock sale
4. The same animal con not compete in market & jackpot
5. If animals do not make weight they will be moved to the jackpot show.

## MARKET BEEF SHOW

### 1100 –pound minimum

1. Only steers will be eligible.
2. Steers with horns or scurs cannot be entered in the show.
3. All steers must be fitted and be halter broken.
4. Steers are to be cross- tied in the stall with one rope around the neck and one from the halter.
5. Show halters are required in the show rings.
6. **BRAND INSPECTION:** The law in effect at show time will be enforced. Beef coming from Washington must have a Washington Brand Inspection Certificate.
7. Steers must be left tied with a halter after the sale.

### SPECIAL BEEF RE-SALE RULES

1. All show market steer live grades will be considered as estimates, with the show not responsible for live grade. The estimated value of market steers will be used only to establish a minimum sale bid price.
2. Exhibitors with steers going to slaughter as resale animals will be paid the carcass rail value for the animal, plus the dollar amount bid above the announced minimum bid price at the auction sale, less the sale's commission.
3. Exhibitors with steers going directly to the buyer for locker meat will receive the sale transaction price less the sale's commission

## MARKET LAMB SHOW

### 105-140 Pounds

1. Only wether or ewe lambs will be eligible.
2. **All lambs exhibited must have a Premise ID or Scrapie Ear Tag. For information call USDA at 866-873-2824.**
3. **Any lamb showing evidence of sore mouth, foot rot, contagious fungal infection, or any unsightly conditions will be asked to leave immediately.**
4. Lambs not properly castrated will not be eligible to be shown or sold. Testicles must be removed from body.
5. All lambs must be shorn before weighing in.

## MARKET SWINE SHOW

### 230-280 pounds

1. Only barrow or gilt hogs will be eligible.
2. The show board reserves the right to ring any hog causing disturbance.
3. No artificial substances, such as oil or powder, may be used in fitting of swine.
4. **NO BODY CLIPPING!** Ears and Tails only.

# **JACKPOT BEEF DIVISION**

1. STEER CLASSES WILL BE DIVIDED BY WEIGHT INTO AS EQUAL GROUPS AS POSSIBLE BY THE MANAGEMENT.
2. ALL HEIFERS MUST BE CALFHOOD VACCINATED.
3. NO SHOWMANSHIP REQUIRED FOR JACKPOT ANIMALS.
4. NO CROSS ENTRY WITH MARKET STOCK SALE
5. JACKPOT ANIMALS ARE RELEASED AT 5 P.M. FRIDAY

## **STEER SHOW**

**Entry Fee:** \$25.00 per steer

The management will retain \$10.00 of each \$25.00 fee for administration purposes. The remaining \$15.00 will be split on a percentage basis per class depending on the number of entries per class.

**Weights:** 700 lb. minimum

**Limits:** No exhibitor shall receive more than two cash awards in one class

**Awards:** Buckles will be presented to Grand Champion and Reserve Grand Champion Steers

## **HEIFER SHOW**

1. Any breed with a minimum of ten (10) head will be offered a Breed show. An "Any Other Breed" show will be offered for breeds with less than ten head.
2. Breeding heifers will be divided into classes according to age.
3. Exhibitors will present registration papers or breeders certificate verifying date of birth for individual heifers upon acceptance to the show grounds.
4. No nursing calves – No cows.

**Entry Fee:** \$25.00 per heifer

The management will retain \$10.00 of each \$25.00 fee for administration purposes. The remaining \$15.00 will be split on a percentage basis per class depending on the number of entries per class.

**Classification:** Senior Calf born September 1, 2008 to December 31, 2008  
Intermediate born May 1, 2008 to August 31, 2008  
Junior born January 1, 2008 to April 30, 2008  
Senior born September 1, 2007 to December 31, 2007

**Limits:** No exhibitor shall receive more than two cash awards in one class

**Awards:** Buckles will be presented to Grand and Reserve Champion Heifer

# **JACKPOT SHEEP DIVISION**

1. A LAMB MAY BE ENTERED IN AS MANY CLASSES AS THEY QUALIFY FOR IF ADDITIONAL ENTRY FEES ARE PAID.
2. NO SHOWMANSHIP REQUIRED FOR JACKPOT ANIMALS.
3. NO CROSS ENTRY WITH MARKET STOCK SALE.
4. JACKPOT ANIMALS ARE RELEASED 5:00 FRIDAY.
5. PEE WEES MAY ENTER THE JACKPOT SHOW.
6. LAMBS NOT PROPERLY CASTRATED WILL NOT BE ELIGIBLE TO BE SHOWN. TESTICLES MUST BE REMOVED FROM BODY.

## **LAMB SHOW**

**Entry Fee: \$25.00 per lamb**

The management will retain \$10.00 of each \$25.00 fee for administration purposes. The remaining \$15.00 will be split on a percentage basis per class depending on the number of entries per class.

**Weights:** 50 lb. minimum

**Limits:** No exhibitor shall receive more than two cash awards in one class

**Awards:** Buckles will be presented to Grand Champion and Reserve Grand Champion

## **EWE SHOW**

**Entry Fee: \$25.00 per ewe**

The management will retain \$10.00 of each \$25.00 fee for administration purposes. The remaining \$15.00 will be split on a percentage basis per class depending on the number of entries per class.

**Classification:** Junior Ewe Lamb born January 1, 2009 or later  
Fall Ewe Lamb born September 1, 2008 to December 31 2008  
Yearling Ewe born January 1, 2008 to August 31, 2008

**Limits:** No exhibitor shall receive more than two cash awards in one class

**Awards:** Buckles will be presented to Grand and Reserve Champion Ewe

## **JACKPOT SWINE DIVISION**

1. A HOG MAY BE ENTERED IN AS MANY CLASSES AS THEY QUALIFY FOR IF ADDITIONAL ENTRY FEES ARE PAID.
2. NO SHOWMANSHIP REQUIRED FOR JACKPOT ANIMALS
3. NO CROSS ENTRY WITH MARKET STOCK SALE.
4. HOGS MUST BE IDENTIFIED PRIOR TO ARRIVAL.

## **BARROW OR GILT SHOW**

**Entry Fee: \$25.00 per hog**

The management will retain \$10.00 of each \$25.00 fee for administration purposes. The remaining \$15.00 will be split on a percentage basis per class depending on the number of entries per class.

**Weights:** 100 lb. minimum

**Limits:** No exhibitor shall receive more than two cash awards in one class

**Awards:** Buckles will be presented to Grand Champion and Reserve Grand Champion

## **BREEDING GILT SHOW**

**Entry Fee: \$25.00 per gilt**

The management will retain \$10.00 of each \$25.00 fee for administration purposes. The remaining \$15.00 will be split on a percentage basis per class depending on the number of entries per class.

**Classification:** Spring Gilt – Born on or after 1-1-09 and before 2-28-09  
Winter Gilt - Born on or after 11-1-08 and before 12-31-08  
Fall Gilt – Born on or after 9-1-08 and before 10-31-08

**Limits:** No exhibitor shall receive more than two cash awards in one class

**Awards:** Buckles will be presented to Grand and Reserve Champion Gilt

# SHOWMANSHIP

1. Showmanship is mandatory for market stock sale exhibitors.
2. Entry in showmanship for jackpot exhibitors is not required.
3. Contestants shall show their own animals, except Peewee lambs. Breed type and conformation will not be considered. All fitting shall be done prior to the contest.
4. 4-H & FFA will show together in showmanship.
5. If an exhibitor becomes champion showman in two animal areas, this exhibitor shall have the choice of animal area to enter in the all around and the reserve champion will step up in the other animal area.

## SHOWMANSHIP CLASSES GRADE TO BE COMPLETED IN 2009

Pee Wee (sheep & swine only) Pre 4-H age  
Junior 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, & 6<sup>th</sup> Grades  
Intermediate - 7th, 8th & 9th grades  
Senior - 10th, 11th & 12th grades

**AWARDS:** Buckles will be presented to division champions

# ALL-AROUND SHOWMANSHIP

1. Champion exhibitors of each age division within each species will show all three species within their age group.

## **AWARDS:**

Monogrammed items will be presented to Champions in the Junior, Intermediate, and Senior Divisions.

# JUDGING CONTEST

## KATHY MAYFIELD, SUPERINTENDENT

Contest is open to all 4H members and FFA members. Teams must consist of a **minimum of three** and a **maximum of five members** from within the same 4H Club or FFA Chapter. **JUDGING TEAMS MUST BE DESIGNATED PRIOR TO THE CONTEST.** Top three scores will be used as team scores. Leaders and Advisors may pre-register their judging teams on forms provided in the show pre-registration package. Confirm registration and pick up supplies before the contest begins at the show office. The Hormel scoring method will be used. Awards will be on an individual and team basis. FFA alternate judges are eligible for individual awards.

**Awards to FFA Winners**                      1st, 2nd and 3rd teams; Banners  
1st (individual); Banner  
Appropriate certificates to top 10 individuals

**Awards to 4-H Winners**                      1st, 2nd and 3rd teams; Banners  
Overall high individual; Banner  
Appropriate certificates to top ten Senior, Intermediate, and Junior individuals

The Judging Superintendent, the Species Superintendent, and the Species Judge shall collectively select the animals to be used in the judging contest and set up the classes.

# HERDSMANSHIP

## HERDSMANSHIP IS IMPORTANT

### Basis for Scoring

Exhibitors earn points by maintaining clean, neat stalls. Barns that are clean and orderly, including alleys, stalls and pens, earn points. Points are earned if your animal remains securely tied or penned and is kept clean and comfortable. Your animal(s) must be regularly fed and cared for. If your feed, equipment and stall cards are in place and orderly, points will be added. Participants who are friendly, courteous, and cooperative and conduct themselves in a manner that will make their club or county proud will earn points. When the appearance of your stall is poor, points are deducted. When animals are neglected or noticeably distressed, points will be deducted. When these areas are in poor condition, points are deducted.
